#### **Program Description**

The MSc in Nursing Administration is a program designed to enable students to play the role of leaders and managers at different levels of the healthcare system. Graduates of the program will be able to improve the quality of healthcare services, using their managerial knowledge and skill. As such, the health system can benefit from managerial expertise of the graduates in Nursing Administration to establish, administer, develop, and run hospitals. To this end, the Departments of Nursing Administration were first set up at several faculties of medicine schools namely Maryland, John Hopkins, Houston, and UCLA during 1970s. The aim of these departments was to train registered nurses who sought additional education to earn a Master of Science in Nursing or Doctor of Nursing Practice to prepare for leadership roles within nursing and Public Health programs. In line with such objectives, Tehran University of Medical Sciences has been offering Master of Science degree in Nursing Administration since it was launched in 1987.

#### **Admission Requirements:**

- Holding a BSc degree in nursing received from accredited universities in Iran or abroad
- Participating in and obtaining the required pass mark from an Entrance Exam held nationwide for the applicants seeking a master's degree
- Being in good mental and physical health

- Verbal and written assessment [multiple choice questions (MCQ), Essay]
- Interactive computer test
- Practical assessment (projects, portfolio, logbook, and lab observations).
